

### Commitment to the Fairtrade system and movement

## COMMITMENT TO FAIRTRADE

Fairtrade Australia and New Zealand (Fairtrade ANZ) recognises the contribution to the wider Fair Trade movement made by companies which either have membership of the World Fair Trade Organisation (WFTO), or apply the FAIRTRADE Mark to all products that they sell in a specific Fairtrade product category.

# COMMITMENT TO FAIRTRADE LICENCE FEE DISCOUNT

Fairtrade ANZ believes such commitments should be acknowledged by offering discounts to the standard licence fee for these companies.

Fairtrade ANZ offers the following discounts in the licence fee for use of the Fairtrade Mark:

DISCOUNT	APPLICABLE LICENSEES
25% discount	World Fair Trade Organisation Members (www.wfto.com)
25% discount	Licensees which sell 100% of a product category carrying the Fairtrade Label

#### **ELIGIBILITY**

To be eligible for the discount, companies must submit the Commitment to Fairtrade application form along with the relevant documentation, and be operating in conformity with the Fairtrade ANZ Licence Agreement.

#### **BREACH OF REQUIREMENTS**

Where Fairtrade ANZ identifies a breach of the requirements, the reduced fee rate will be immediately withdrawn. Fairtrade ANZ may also request payment of any reduced fee that the licensee may have claimed without proper entitlement.

### DEFINITION OF PRODUCT CATEGORY

The basis for a product category is the ingredients for which Fairtrade Standards are available. Under Fairtrade Standards A product category therefore can either be:

- a single products, such as coffee, tea, rice, nuts. These are composed of a a single type of ingredient that may be from a single Fairtrade origin or may be a mixed blend of origins that are all Fairtrade:or
- a composite products such as chocolate, consisting of a mixture of different ingredients, providing that all ingredients that can be Fairtrade (ie for which Fairtrade Standards are available) are Fairtrade and that the product has been approved by Fairtrade ANZ in accordance with the Fairtrade Composite Porduct Standard.
